Warranty

Arbour Landscape Solutions warrants that for a period of 10 (ten) years, under normal use, Arbour Landscape Solutions warrants that Arbour Landscape Solutions wood plastic composite products will not split, splinter, rot or twist and it will be free from any material or manufacturing defect.

The limited warranty of 10 years is from the date of purchase, if any products are defective during this 10-year period then Arbour Landscape Solutions shall replace the products at no charge.

This warranty shall not cover and Arbour Landscape Solutions shall not be responsible for costs and expenses incurred with respect to the removal of defective Arbour Landscape Solutions products or the installation of replacement materials, including but not limited to labour and freight.

To make a claim under this limited warranty, the customer will send to Arbour Landscape Solutions, within the warranty period referred to above, a description of the claimed defect (including photos of the defect) and proof of purchase.

This Warranty covers the wood plastic composite products the clips and fixing system provided by Arbour Landscape Solutions.

Limitations

Arbour Landscape Solutions does not warrant against and is not responsible for, and no implied warranty shall be deemed to cover, any condition attributable to:

- **1.** Improper installation of Arbour Landscape Solutions products and/or failure to abide by Arbour Landscape Solutions installation guidelines, including but not limited to improper gapping.
- **2.** Use of Arbour Landscape Solutions products beyond normal use, or in an application not recommended by Arbour Landscape Solutions guidelines and local building codes.
- **3.** Movement, distortion, collapse or settling of the ground or the supporting structure on which Arbour Landscape Solutions products are installed.
